

FINE-HAMMOND DANCE STUDIO
RELEASE/ENROLLMENT FORM

- I UNDERSTAND THAT TUITION IS DUE THE FIRST LESSON OF EACH MONTH AND A \$10 LATE FEE WILL ALSO BE REQUIRED IF TUITION IS NOT PAID BY THE 10TH OF EACH MONTH. I UNDERSTAND THAT MY CHILD MAY NOT BE ALLOWED TO CONTINUE PARTICIPATION IN CLASS IF TUITION IS CONSISTENTLY LATE EACH MONTH. I ALSO UNDERSTAND THAT TUITION IS REQUIRED FOR EACH OF THE NINE (9) MONTHS THROUGHOUT THE FALL/SPRING SEASON AND THAT THE STUDIO WILL NOT TOLERATE A "SKIPPED" MONTH OF TUITION.
- IN ADDITION TO MONTHLY TUITION FEES I UNDESTAND THAT I WILL ALSO BE REQUIRED TO PAY A ONCE-PER-YEAR ENROLLMENT FEE, RECITAL FEE, AND COSTUME FEE AND THAT OTHER ADDITIONAL NOTICES WILL BE GIVEN BEFORE THESE FEES ARE DUE.
- I UNDERSTAND THAT I MAY CALL THE STUDIO TO REQUEST A "MAKE-UP" CLASS IF MY CHILD IS EVER ILL OR ETC. AND HAS TO MISS A CLASS FOR SOME IMPORTANT REASON. I ALSO UNDERSTAND THAT TUITION IS PAID ON A FLAT RATE BASIS, NO MATTER HOW MANY LESSONS THERE ARE IN A GIVEN MONTH AND THE STUDIO WILL NOT GIVE REFUNDS FOR MISSED CLASSES.
- I UNDERSTAND THAT WHENEVER EXCELSIOR SPRINGS PUBLIC SCHOOLS ARE CLOSED DUE TO A "SNOW DAY" (BAD WEATHER ONLY) THE STUDIO WILL ALSO BE CLOSED AND THESE CLASSES WILL NOT BE MADE UP. I UNDERSTAND THAT STUDIO CLASSES WILL BE CANCELLED FOR LABOR DAY, THANKSGIVING BREAK, CHRISTMAS BREAK AND NEW YEAR'S DAY. REGULAR CLASSES WILL STILL TAKE PLACE ALL OTHER HOLIDAYS! IF A SIGNIFICANT AMOUNT OF CLASSES ARE CANCELLED DUE TO BAD WEATHER, ADDITIONAL CLASSES WILL BE SCHEDULED TO MAKE UP FOR THE MISSED CLASSES, AT THE TEACHER'S DISCRETION.
- I UNDERSTAND THAT PARENTS ARE PERMITTED AND ENCOURAGED TO WATCH CLASSES INSIDE THE STUDIO DURING THE THREE "PARENT OBSERVATION WEEKS" ONLY AND THEY ARE ALSO WELCOME TO OBSERVE CLASSES THROUGH THE FRONT STUDIO WINDOWS AT ANY TIME.
- I UNDERSTAND THAT CONSISTENT ATTENDANCE IS A REQUIREMENT AT THE STUDIO. I ALSO UNDERSTAND THAT IF CONSISTENT ATTENDNANCE BECOMES A PROBLEM, MY CHILD MAY BE ASKED TO PERFORM THEIR CLASS ROUTINES (IN SOLO FORM) FOR THEIR INSTRUCTOR TO DEMONSTRATE THEIR "READINESS" FOR THE RECITAL PERFORMANCE. IF IT APPEARS THAT MY CHILD HAS NOT LEARNED THEIR CLASS ROUTINES SUFFICIENTLY FOR THE SPRING RECITAL, HE OR SHE MAY BE ASKED NOT TO PERFORM.
- I UNDERSTAND THAT MY CHILD MUST ATTEND ANY REQUIRED REHEARSAL THAT IS SCHEDULED BEFORE ANY UPCOMING PERFORMANCE IN ORDER TO BE IN THAT PERFORMANCE.
- I UNDERSTAND THAT STUDENTS ARE REQUIRED TO ARRIVE ON TIME FOR THEIR CLASS AND CONSISTENT "TARDINESS" TO CLASS WILL NOT BE TOLERATED. I ALSO UNDERSTAND THAT AS A PARENT I NEED TO CALL THE STUDIO TO REPORT MY CHILD'S ABSENCE OR TARDINESS WHENEVER THIS SHOULD OCCUR.
- I UNDERSTAND THAT STUDENTS MAY NOT ENTER THE STUDIO UNTIL 5 MINUTES BEFORE THEIR CLASS, UNLESS GIVEN SPECIAL PERMISSION. I ALSO UNDERSTAND THAT I MUST ALSO BE READY TO PICK UP MY

CHILD WHEN THEIR CLASS TIME IS OVER AND A \$10 FEE WILL ALSO BE CHARGED FOR EVERY 10 MINUTES MY CHILD CONTINUES TO WAIT FOR THEIR RIDE AFTER CLASS IS OVER.

- I UNDERSTAND THAT PRACTICE IS A VERY IMPORTANT PART OF DANCE TRAINING AND STUDENTS ARE EXPECTED TO CONSISTENTLY PRACTICE THE MATERIAL THEY ARE WORKING ON IN THEIR SPECIFIC CLASSES.

- I UNDERSTAND THAT MY CHILD MUST WEAR THE APPROPRIATE "CORRECT" DANCEWEAR AND DANCE FOOTWEAR TO EVERY CLASS IN ORDER TO WORK PRODUCTIVELY EACH WEEK. I UNDERSTAND THAT APPROPRIATE "COVER UP" ATTIRE MUST BE WORN TO AND FROM CLASS EACH WEEK AND THAT HAIR MUST BE PULLED BACK IN A PONYTAIL.

- I UNDERSTAND THAT A MONTHLY NEWSLETTER WILL BE GIVEN TO MY CHILD DURING THE FIRST OR SECOND WEEK OF EACH MONTH. AS A PARENT, I UNDERSTAND THAT I AM REQUIRED TO READ EACH NEWSLETTER TO GET IMPORTANT INFORMATION THAT PERTAINS TO MY CHILD'S DANCE TRAINING,

- I FULLY UNDERSTAND THAT STUDENTS MAY INJURE THEMSELVES AS A RESULT OF THEIR PARTICIPATING IN THIS DANCE PROGRAM. I HEREBY AFFIRM THAT MY CHILD (OR MYSELF) IS IN GOOD PHYSICAL CONDITION AND DOES NOT SUFFER FROM ANY DISABILITY WHICH WOULD PREVENT OR LIMIT MY CHILD'S FULL PARTICIPATION (OR MY PARTICIPATION) IN THIS DANCE PROGRAM. IN CONSIDERATION OF PARTICIPATION WITH FINE-HAMMOND DANCE STUDIO, FOR MYSELF, MY HEIRS AND ASSIGNS, I HEREBY RELEASE FINE-HAMMOND DANCE STUDIO AND ITS INSTRUCTORS FROM ANY CLAIMS, DEMANDS AND CAUSES OF ACTION ARISING FROM MY CHILD'S PARTICIPATION (OR MY PARTICIPATION) IN THE DANCE PROGRAM. I ALSO FULLY UNDERSTAND THAT FINE-HAMMOND DANCE STUDIO IS NOT RESPONSIBLE FOR PROPERTY LOSS OR FOR ACCIDENTS THAT MAY OCCUR IN OR AROUND OR ON THE STUDIO PREMISES OR AT ANY STUDIO FUNCTION.
