

Fine-Hammond Dance Studio

Summer Session Release/Enrollment Form

- I understand that Summer Session tuition fees are due in full no later than June 1st, 2024.
- I understand that if a student participates in 2 summer session classes, and decides to withdraw from the remaining classes, only half of the summer session tuition will be refunded. If a student participates in half of the summer session and decides to withdraw from the remaining classes, **no refund of tuition will be given.**
- I understand that tuition discounts will not be given when a student is absent from class. Should a schedule change occur and a class be canceled by the studio, a different re-scheduled “make up” class will be scheduled. Tuition will not be affected.
- I understand that parents are not permitted to observe classes inside the studio, but are welcome and encouraged to observe classes through the front studio windows at any time. A ‘parent observation week’ is scheduled for the last day of summer classes, at which time parents are encouraged to attend and observe class inside the dance studio.
- I understand that students are required to arrive on time for their class and consistent ‘tardiness’ to class will not be permitted. **I also understand that as a parent I need to call or text the studio to report my child’s absence or tardiness whenever this should occur.**
- I understand that students may not enter the studio until 5 minutes before their class, unless given special permission. I also understand that I must also be ready to pick up my child when their class time is over and a **\$10 fee** will also be charged for every 10 minutes my child continues to wait for their ride after class is over.
- I understand that my child must wear the appropriate “correct” dancewear and dance footwear to every class in order to work productively each week. I understand that hair must be pulled back in a ponytail/bun or braid, and short hair must be pulled back out of the face.
- **I fully understand that students may injure themselves as a result of their participating in this dance program. I hereby affirm that my child (or myself) is**

in good physical condition and does not suffer from any disability which would prevent or limit my child's full participation (or my participation) in this dance program. In consideration of participation with Fine-Hammond Dance Studio, for myself, my heirs and assigns, I hereby release Fine-Hammond Dance Studio and its instructors from any claims, demands and causes of action arising from my child's participation (or my participation) in the dance program. I also fully understand that Fine-Hammond Dance Studio is not responsible for property loss or for accidents that may occur in or around or on the studio premises or at any studio function.
